BENEFITS AND OBLIGATIONS OF MEMBERSHIP:

SKI PROGRAMS: Active skiing members are entitled to participate in the following programs for year from the date of membership:

Show Ski Program

Directed toward developing teamwork, this session offers instruction and practice in show ski techniques such as pyramids, line ups, double and trio acts, and other team acts. The two-hour group session is held once or twice per week. Full members are also eligible for a 30-minute ski session per week for instruction or practice. Sessions are scheduled at the availability of the boat drivers.

Learn-to-Ski Program

Directed toward developing skiers, this option offers three 30-minute instructional sessions with one of our boat drivers. Scheduling will be done at the availability of boat drivers and participants. If a participant wishes to continue in the Show Ski program, the Learn-to-Ski fee will be subtracted from the standard membership fees.

Note: All programs are offered during the ski season—June through September pending suitable weather and boat driver availability.

Family memberships: includes parents and dependent children. All children aged 11 and under are required to have a parent or guardian on site when they participate in any CLWSC activities.

CLUB BYLAWS AND STANDARDS OF CONDUCT: Members are expected to adhere to the requirements described in the Club’s By-Laws and Standards of Conduct documents.

INSURANCE: It is recommended that all active club members have either adequate medical insurance or personal accident insurance prior to participating in any Club activities.
